The audit took place on April 2019 (Start date: 03-04-2019; End date: 11-04-2019; Duration (days) 15 Total).

The assessment covered the period from 03/23/2018 until 03/22/2019. The next assessment has to be successfully finalized before 04/30/2020.

The Organization ANF Autoridad de Certificación Asociación, ANF AC, that carries out the function of Trust Services Provider (TSP) is considered compliant to the requirements of the (EU) REGULATION no. 910/2014 (eIDAS) as regards the electronic identification and trust services for the electronic transactions in the internal EU market.

The Issuing certificate service object of the audit is considered in line with (EU) Regulation no. 910/2014 (eIDAS), and the service digital identities of the services listed below has been verified for the compliance specifically for the two following requirements: a) The Subject Key Identifier as defined in RFC 5280: b) the Base64 PEM representation of the associated X.509v3 digital certificate. Moreover, the Trust Services Provider is conforming as regards Qualified Time Stamping and Issuing Qualified Certificate Service in compliance with the following regulations: (EU) REGULATION no. 910/2014 (eIDAS), ETSI EN 319 401 v2.2.1; ETSI EN 319 421 v1.1.1, ETSI EN 319 411-1 v1.1.1. and ETSI EN 319 411-2 v2.2.1.
